## From Your President:

Those of us in the Capital District for this election round were more fortunate than those who had spent some early spring time in Florida. These snow birds were inundated with TV commercials from the primary candidates that brimmed over with vile and bile aimed at their opponents. If it wasn't the candidates themselves, it was their super pacs that liked them or hated another candidate. They filled in the time when the candidate did not. It was our good fortune to be spared that TV flood in New York, if not a zillion phone calls!

That is the good news. The bad news is that it is not November yet! There is still time to be driven to distraction by the incessant attacks on some candidate or other. But in the meantime, reflect on what you can or cannot do. The vital step you took or chose to pass up is the part of the voter registration form where you were asked to designate a party. If you did not select one party or another, you gave up your chance to decide the candidate for November. Members choose who leads the club, not other interested but outside parties. **If you want a say, you need to enroll in a party.** That does not mean that you will vote for the person your enrolled party chooses. You can vote for any candidate on the Ballot. It does mean that you can shape the choices offered to voters. In many areas of our state, one party dominates local elections. If you are not in that party you really do not have a meaningful vote. The dominant party's candidate will most often prevail. The real vote is for who that candidate will be. Members choose that, not all voters. So now is the time to do something about that, while it is on your mind. Enroll in a party that **MOST CLOSELY REFLECTS THE BELIEFS YOU HOLD ON THE ISSUES OF THE DAY.** I did not say pick one that is a perfect match to all of your likes and dislikes. I said one that most closely matches your view.


Why not stick with one who is a perfect match? Well ask yourself if you really think your views are shared by a majority of voters in this country. Check your conclusion against the recent results in the primaries across the nation. Did they match up as you would like them to? Do they want to protect your vital interests or just your basic beliefs? They are not always the same thing, but vital interests are what keep you safe. It's not about appealing to likeminded voters, but it is about reaching those who do not completely agree with those views. It's not about finding a party that is a perfect match. It's about finding a party that can attract enough other voters who share a substantial set of shared vital interest that together can produce a majority. Yes, you need to accept that the choice you made will cause you to occasionally choke on an issue or candidate you need to go with but, overall it comes as close as you can get to what you need.

We have majority rule, not perfect agreement as an operational principle, so in getting to one more than half, you must accept some degree of policy or candidate you don't fully like. That also means those who dislike your choices must live with your ideas and candidate that they do not fully like, in order to get your support. It is a two way street, or else it is a one way street to a dead end of defeat.

That is not always possible if the most extreme candidates in the party are the only ones to get a respectable showing in a primary. If the offerings are a choice between bad and worse, we have only ourselves to blame. Often we do not vote in primaries. The most extreme members of a party are those who are most unhappy with the status quo and hence turn out for primaries in the hope of getting a nominee who is a perfect match to their view. The irony of that is that if they win by our neglecting to vote, then we all lose!

To win requires the building of a majority. To govern requires the building of majority opinions and support on issues. "My way or the highway" is not an approach that can do that. Failure to respect the results of an election, like it or not, does not do that. We elected a President in 2012 for four years. Now we are told that during his last two years he cannot name a Supreme Court judge because we need to wait until the next vote. What about the votes of those who elected him for four years? How can they be ignored in favor of some who have not yet voted at all? The nominee on the docket at this moment is one who can go either way in his decisions. Every conservative can find something to like in his record. Every liberal can find things that they like in his record. No one at either extreme can find a guarantee that he will always agree with them. That is what majority government is always about. If you do not stay involved, you may not like what happens. It's not enough to stack the deck with likeminded folks and then ignore what happens. You must be enrolled, involved, voting and informed, or you will get what you like least and hate most.

## RC10 Members at the Committee of 100 Lobby Day By Bonnie Maxon

On March 8, the NYSUT Committee of 100 lobbied for public K-12 and higher education at the State Legislature. The following issues were discussed in meetings with legislators: Lack of funding for Teacher Centers, School Aid, Tax Cap, Charter Schools, and Oppose School Voucher Schemes (Parental Choice In Education Act). This year, NYSUT provided us with a two-sided sheet that explained all 21 issues in detail. We asked for the GEA (Gap Elimination Adjustment) to end, and for a tax cap that is the true 2% or cost of living, not whichever amount is lower.

RC10 members who lobbied included Bonita Maxon, Dennis Bouchard, Vince Pelliccia, and Deb Escobar. They attended meetings with Assemblymembers Steve McLaughlin, Carrie Woerner, Angelo SantaBarbara, Pat Fahy, and Pete Lopez as well as Senator Farley, Senator Amedore, and a representative from Senator Marchione's office. They came away realizing the importance of explaining our positions to our elected officials. Many of them expressed surprise at various aspects of the issues surrounding funding, and the harm that charter and vouchers do to the public school tax stream. We encourage all RC10 members to advocate for education by contacting their legislators.
