## From Your President:

in the end?

Election time is just around the corner. Soon ads will be filling your TV screens and newspapers. Many, of course, are "Vote for me" types. But this year, as we all know, there is another campaign and it is one calling for a Constitutional Convention to change the NY State Constitution. The occurrence of such a vote is required to be held by the present constitution. It does not require that we actually do it, only that we have a chance to vote on that referendum

What is at stake for us if we do hold such a convention? Presently when we have a question on the ballot about changing the existing document, we know the issue and can make a choice to do it or not. When we vote for a Constitutional Convention, we are agreeing to let others make any changes they want and put together things as they like with things that might hurt us, and we say take it or leave it all. Once the door is open anything may be changed. There is no part of the constitution as it now exists that cannot be altered or deleted. Michael Andrew of RC 21 recently wrote, "Democracy is based upon the intellectual debate of ideas and the resulting compromises that both sides of the debate make." He sure got that right! Will your pension security be a victim of compromise? Will the Adirondack forest preserve be lost to a back-room deal?

Some of us believe Federal law, not the state constitution, really protects our pension. Recently the Teamsters in our state faced a demand to cut existing pensions. Those members who voted for the most part said no. But those who did not vote were counted as yes votes by federal law. It passed, 1,000 votes no to 29,000 nonvoters counted as yes. That is federal law at work. Does it work for you? Ask a Teamster retiree how that federal protection worked for him.

Are you willing to let a future legislature reduce an already retired worker's pension? Our present constitution makes that impossible. They can create new plans but not take away existing ones. That is why we have tier 2 and tier 3, etc. Those in existing tiers could not have their benefits reduced after they had already earned that benefit. No Federal law prevented that. Our state constitution did and continues to do so--unless we allow a convention that can change the rule. That lets someone play let's make a deal in some smoke-filled room, at our expense. That resulting package of good and bad will be pushed for the good in it, and the bad will be overlooked or seen as your problem, not my problem.

Do you want the legislature to reduce workers compensation payments

already granted, just because they want to make some money available to some other cause? Can't do that right now, but some folks want to do that in the future and so they support a convention where their money talks.

Do you want to lose agency fee and have some free loaders get the benefits and pay that you worked for

without helping to pay their share of the cost of getting them? If you get it for free, who will pay. If no one has to pay, who will do the work to get or continue the benefits? Everyone employed loses out when that happens. By the time you realize what you were getting for your dues, you won't have the benefits to protect.

We have the Blaine Amendment in the New York State Constitution that prohibits expenditures of public funds in support of religious schools. Some folks want public funding for their faith and not the other person's faith. The impact of that law looks quite different now. That has traditionally been a debate between mostly Christian and Judaic religious enthusiasts. Now we have the added presence of Islamic students and some of those of their faith that want state supported schools to raise their children in sharia traditions. But in America, everyone is treated the same. We all get a benefit or no one gets it. If we open that door, we have no way of knowing who will walk through it. We all share government support for all faiths or we all support our own faith

Should the legislature have input into what goes into the state budget, or do they just say yes or no to whatever the Governor puts there. What is the budget price of a legislative vote becoming the real question? Present law has weakened the role of the Legislature in drafting state budgets. Should we end the division of power principle that maintains the balance between Executive, Legislative and Judicial in NY? It can be done away with entirely if we open the Constitution. Should a back room deal at a convention be permitted to change that?

The State Bar Association has just called for passage of the convention proposition. They claim there is a mass of arcane laws that require sweeping changes. It seems they believe that only those who wrote or litigated these arcane laws can be trusted to fix what they have wrought! A massive, technical change in numerous laws all hidden in plain sight is not the way to achieve improvement. # RC 10 MEMBERS STAND UP TO SAY ALL CHILDREN DESERVE A QUALIFIED TEACHER!

On Tuesday, September 12, 2017, 60 education activists united in Saratoga to tell the SUNY Board of Trustees that all students deserve highly qualified teachers. The protest came about as a result of a proposal to alter teacher certification requirements for charter schools, requiring only 30 hours of hands-on classroom experience, and another 100 hours of observations. Charter schools would be able to design their own training plans for certifying their teachers, a problem considering that profit potential might incentivize shoddy requirements, and that charter schools are well known for their lack of transparency and lack of cooperation with state authorities.

The change in certification requirements would, in essence, create a two-tier system that would say that one child is entitled to a highly certified teacher, and another child is not. Given that charter schools set up in areas with high poverty rates and families of color, those communities would be impacted the most. Assemblywoman Carrie Woerner (D-Round Lake) stated that the harm to struggling communities would not be acceptable. Brown v. the Board of Education demanded that every student receive an equal education. The change being proposed would reverse Brown by allowing the separate and unequal quality of teachers. Andy Pallotta, President of NYSUT, asked for "social justice for all students."

Some of the RC 10 members who attended the event included Jane Weihe, Dennis Bouchard, Vince Pelliccia, and Tony McCann. They joined NYSUT officials, active teachers, retirees from other regions, nurses, and members of CSEA, Citizen Action, Working Family Party, Alliance for Quality Education and others.

Billy Easton, Executive Director of the Alliance for Quality Education, spoke to the SUNY Board for the group. Calling the plan "unconscionable," he presented the trustees with a letter signed by 40 community groups including the NY NAACP and other civil rights organizations. ### RC 10 MEMBERS ASKED TO VOTE "NO" ON STATE CONSTITUTIONAL CONVENTION

In November, voters will be asked to decide if New York will hold a convention to rewrite our state constitution. This would be a multi-million dollar waste of taxpayer money and would give special interest groups and power brokers the opportunity to change the constitution for their own interests. NYSUT President Andy Pallotta has warned that a Constitutional Convention "could spell complete disaster for New York State's public education system."

Opening up the constitution for an overhaul could derail vital rights that we have as New Yorkers, including public service pensions, environmental protections, as well as a free public education for our children. Public schools have continually been under assault by hedge fund investors who are pushing charter schools, voucher



schemes, and a fast-track to teacher certification. The last time a Constitutional Convention was held, there was a proposal to repeal the Blaine Amendment that was barely defeated. This valuable provision in our constitution prohibits the use of state tax money to fund religious schools. Without this protection, public schools will be devastated by a further loss of funding. We cannot afford to let this happen. It is critical that we be informed and reach out to educate others on the need to VOTE NO on the referendum that will be on the back page of our ballot on November 7.
