PROTECT MEDICARE, MEDICAID AND SOCIAL SECURITY

In December the Senate passed what one New York Times op-ed called the "biggest tax scam in history." A sweeping tax reform which promises to give the middle class a tax cut will actually add \$1.4 trillion to the national debt over ten years, with most of the benefits going to the top 1%. This bill will have repercussions across our nation, starting with the fact that it will leave 13 million more people uninsured because the bill ends Affordable Care subsidies. This will destabilize the insurance market, causing massive hikes in premiums for everyone, including those on retiree insurance plans.

Perhaps most troubling have been the statements from GOP leaders in both the House and Senate that state they will look to balance their ridiculous giveaway to the rich by cutting what they call "entitlements" -- Social Security, Medicare, and Medicaid. The cuts to Medicare may begin without any additional legislation because of "pay-as-you-go" rules that require that any tax cut that isn't paid for (and this truly is a deficit bill) will trigger automatic spending cuts under Congressional rules. Though GOP leaders have promised they would waive the pay-go requirement, this would contradict statements they have given to the press which blame the national debt on earned benefits programs. In addition, the nonpartisan Congressional Budget Office has stated that the White House Office of Management and Budget (OMB) will be required to order reductions for the anticipated \$136 billion shortfall in 2018. If this happens, Medicare would be cut by about \$25 billion, but there would also have to be major cuts in other programs to make up the shortfall. According to FactCheck.org, some of the programs mentioned for possible cuts would include "Medicare, agricultural subsidies, student loans, the Social Services Block Grant, parts of border security and mandatory spending in the Affordable Care Act other than exchange subsidies (already gone in the bill) and Medicaid expansion...Most affected programs other than Medicare would be wiped out."

We must continue to ask that Congress protect Medicare and other social safety net programs. Democrats have some leverage at long last because 60 votes will be required for any government funding legislation to pass. This issue is critical for retirees. Social Justice Committee News

As part of RC 10's ongoing commitment to Social Justice, our Council will be participating in the Regional Foodbank's BackPack Program. This program is designed to meet the needs of hungry children on weekends when other food resources are not available. The program provides bags filled with food that are child-friendly, shelf-stable, and easily-consumed. Bags are packed each week by school staff and discreetly distributed to participating children every Friday afternoon. The bags are then returned on Monday to be refilled for the next weekend.

In the four counties that RC 10 represents, the following school districts currently have a Regional Food Bank BackPack Program: Albany, Argyle, Averill Park, Berne-Knox-Westerlo, Burnt Hills-Ballston Lake, Brunswick-Brittonkill, Capital Region BOCES, Cohoes, Corinth, Fort Edward, Greenwich, Guilderland, Hartford, Heatly, Hoosick Falls, Hudson Falls, Lansingburgh, Mechanicville, North Colonie, Ravena-Coeymans-Selkirk, Rensselaer, Schodack, Shenendehowa, South Glens Falls, Stillwater, Troy, Voorheesville, Watervliet, and Whitehall School Districts.

It costs the Regional Food Bank \$183 to support a child for the entire year. There are never enough funds to provide for all the applicants so we are asking for the assistance of RC 10 members to contribute to this very worthy cause. No contribution is too small since our combined efforts will help to sustain the program.
