The news regularly documents stories that describe how fellow citizens are scammed out of money, gift cards, health insurance information and even their homes. Criminals use deceptive methods that often cause significant damage to their victims. It's important to pay attention to the descriptions of how they manipulated their victims so that you don't fall prey to the same scams.

Several years ago, I received a friendly phone call asking if I'd received my new

Medicare card. I *had* received a new card because my status had changed. The caller then asked what the new number was so he could verify I had received the correct card. I immediately remembered that **Medicare officials NEVER ask you for your Medicare number;** and I told the caller that if he gave me the number he had on file, I would tell him if it was correct. He was much less pleasant after that remark and then proceeded to threaten me that the card would not be activated if I did not verify the number. I hung up and then blocked the caller. Giving out your Medicare number to someone that calls you may allow that individual to unlawfully use your number for unspecified charges.

One very successful scam that continues to circulate is from a caller claiming to represent a technology company like Microsoft, Norton, or Apple. The caller tells the recipient that their computer has been hacked and that for a fee, they will "fix" the infected computer. Victims in the US lost millions of dollars to this scheme. **Hang up on all calls providing a service you never asked for.** If you are unsure if it might have been a legitimate call, you can find contacts by going to confirmed websites or looking on your credit card statements for a legitimate phone number, and you can call them back.

If someone calls from your credit card company saying there is an unlawful purchase and asking for you to confirm your account number, hang up and call the number on the back of your credit card to ask if there is in fact a fraudulent purchase. Credit card companies will usually contact you via text and only ask if you made a purchase. They don't need any other information to verify that the purchase was not made by you.

A recent email experience notified me that my virus protection software was out of date, and it was time to renew. It was from the same company I normally use but the dates were off. So, I took the time to make sure my virus software was currently activated and then I searched when I last subscribed. None of my records corresponded to what they were suggesting. Had I clicked on the link they sent, I would have been giving personal information to an unknown source. I now keep a running list of all the subscriptions I have and the dates and the amounts that are charged so that when they come up for renewal, I know if the notification is legitimate.

With all the data breaches many of us have experienced, it might be a good idea to freeze your credit with the three credit agencies. Most of us are not looking to make a major purchase or open new credit cards. By freezing your credit, no one can open new credit cards in your name or make a major purchase that requires a credit check without your knowledge. If you or a vendor needs access to your credit, you can turn your credit back on for the approval process and then turn it off again.

As we begin this new year, it's worth examining how we protect ourselves and our loved ones and vow to make some positive changes for 2025.

- *Shred documents that contain personal information.* Some companies offer shredding days if you don't have access to a shredder. **Do not throw them away!**
- *Update your passwords if you have been using easily identifiable information in those passwords or if you use similar passwords for websites you use most often.* Also consider using an APP that generates and saves those passwords so you don't have to remember those that are complicated. The more

complicated it is, the less likely someone can guess it. Do not use the same or similar passwords for multiple sites.

- *Checks have a lot of personal and identifiable information* on them. (Name, address, routing numbers, etc.) Think about who you are sending a check to and ask yourself if the recipient has a secure mailbox. A few years ago, my Mom sent checks to relatives in greeting cards. One of the cards to a grandchild was stolen and the check inside was cloned and used to make a major purchase in California. The bank covered the purchase but my Mom had to open a new account, order new checks, and was unable to use the account for several days. It was aggravating and required a lot of time to fix.
- *Take a moment to look at who sent an email that doesn't feel right.* Often it will say it's from someone with whom you are familiar but when you scroll over the email address, it's an unknown sender. Delete and report as SPAM

If you become a victim of identity theft, consider the following steps:

- File a report at [IdentityTheft.gov](https://IdentityTheft.gov).
- Notify your bank, credit card company, and other places where you have accounts.
- Contact the three credit bureaus to notify them of the theft and consider putting fraud alerts and security freezes on your credit reports.
- File a criminal complaint with your local police or sheriff's department.

Experiencing any of these scenarios can be challenging and embarrassing. Don't let that stop you from filing a complaint and seeking relief.

If you or someone you know continues to teach using their certificate in any capacity, they will need to complete updated child abuse reporting training by April 1, 2025. All are welcome to complete the training, regardless of whether they intend to teach, as it is informative about the population make-up of the modern classroom.
