June 2025 RC 10 President Barbara McCarthy's Message

Greetings, fellow retirees. I hope this message finds you refreshed and ready to enjoy some good weather. If you stayed in the northeast this past winter, you are undoubtedly looking forward to saying good-bye to the winter we just experienced.

We are now four months into a new presidency and the changes in what we have come to expect in retirement are already reminding us how fragile our retiree lifestyle may be. DOGE (Department of Government Efficiency) has been looking for ways to save money by going after the programs we were relying on to take care of us in retirement. While we were told that Social Security and Medicare would not be on the chopping block, apparently that is not the case.

Offices in many agencies are being closed, employees are being offered exit packages, and probationary workers have been fired despite excellent performance reviews. Many of these folks take with them an institutional knowledge that cannot be replicated, as they have spent years developing their level of expertise. Elderly recipients of Social Security are being asked to appear in person at an office to verify their identity, because they don't have an online account. (Most of our elderly relatives don't have any online accounts!) Calling is not an option if the local office is closed and even if it were open, you may not get through due to the reduction in staff. Some reported being on the phone for hours only to have the call dropped. During the recent Pandemic, I was trying to connect with the IRS to find out where my mom's tax return was. I spent hours on the phone on multiple occasions and was not able to get any results

until I reached out to my congressman. I mention contacting your elected representative because it is their job to assist constituents when faced with unresponsive agencies.

I've been mourning for those that have lost their jobs and

have wondered how we will move forward as a world power if we proceed with the "America First" sentiments that pervade this administration. I recently finished an excellent book that reminded me of what we may face. Who Is Government? The Untold Story of Public Service, compiled and edited by Michael Lewis, is a group of essays by Lewis' favorite authors. Each chapter highlights a government worker who has tirelessly advocated for Americans in one of the agencies we depend upon in our daily lives. I am talking about talented and remarkable people that could have worked anywhere for considerably more compensation, but they chose to devote their lives to public service. One such person includes a young man, named Christopher Mark who grew up in Princeton, NJ, where his father taught and founded a program that combined architecture and engineering. In those classes, his students examined Gothic Cathedrals to determine which architectural features were decorative and which were structurally essential. He gained a lot of notoriety for his research. When it was time for his son, Chris, to choose a college, Chris decided he would rather work in a factory than go to Princeton or Harvard. He kicked around at several jobs and eventually ended up in a West Virginia coal mine. He realized this wasn't a sustainable position for him, so he returned to college at Penn State. He was interested in mine safety but had no idea how he could be trained for such a job and who would hire him. One day, while in a rock mechanics class, his professor lectured students on the formulas used to design the pillars that supported the roofs of coal mines. He was hooked! Having worked in mines he knew that poorly designed pillars killed miners, and that the industry accepted that as the cost of doing business. Chris went on to determine

how to prevent roof collapses in mines. In 2016, it was

noted that there were no deaths in mines from collapsing roofs because of his research. What had changed? Steel roof bolts that were now regularly used instead of cheaper timbers, and **enforcement** of the regulations that governed mine safety. Chris' research as well as his agencies' enforcement of new rules made working in the mines safer than they had ever been.

The book goes on to highlight Ronald E. Walters, head of the National Cemetery Association. Mr. Walters and the 2,300 people that work for his agency are responsible for 155 national cemeteries around the US and bury more than 140,000 veterans and their family members each year. If you've ever visited a national Cemetery, you know what these folks do. Without detailing any more about the eight individuals featured in this book, I can tell you that they highlight some of the most dedicated public servants that work for the federal government. They are all the very best at what they do, and they hire and guide many just like themselves that aren't there for the recognition or for the high salaries they might have received if they worked in the private sector. They are there to provide the very best service to the American people.

We need to push back on the efforts to dismantle the FDA, the CDC, the Department of Education, the Social

Security Administration, Medicare and Medicaid, the National Parks, FEMA, and the National Weather Service to name just a few. These agencies protect us by providing the best scientific evidence needed to guide decisions about our health, safety and well-being. They respond to catastrophic events, to provide relief to those affected by disasters. They protect the vulnerable from those that seek to avoid oversight in unvetted, dangerous and unregulated procedures and jobs. In other words, they are essential to a way of life we have become accustomed to living.

Please call or write letters to your legislators and let them know you are concerned about the gutting of these important agencies. Join a local protest for what you are most concerned about. If you see a local agency struggling to maintain services, consider becoming a volunteer. Last of all, take care of yourselves and pay attention to your personal well-being.

Maintaining NYSUT membership in retirement is crucial, especially if you're currently participating in a NYSUT Member Benefits-endorsed program(s) and would like to continue doing so. This can be accomplished in one of two ways:

- 1 Continue membership within your local if retiree membership is offered. Contact your local to find out if any retiree membership requirements are in place. You must comply with these requirements to continue your membership in NYSUT along with the American Federation of Teachers (AFT) and National Education Association (NEA).
- 2 Continue as an at-large member of NYSUT through the Retiree Council in your region. Contact your local to ensure you will be reported as retired to NYSUT. This will provide you with membership in the Retiree Council in your region along with NYSUT, AFT, and NEA. If you have questions about maintaining NYSUT membership or would like more information about NYSUT retiree programs, you will want to contact the NYSUT Retiree Services Consultant serving your region. You can find this information at nysut.cc/retireeconsultants.

More than a dozen of the endorsed programs offered by Member Benefits can be purchased through either payroll or pension deduction. These convenient payment methods offer reduced premiums or the elimination of service fees in many instances. An active NYSUT membership is required to participate in payroll or pension deduction. If you're currently participating in one (or more) of our endorsed programs, we encourage you to look into switching to pension deduction after you enter retirement.
